First Dakota National Bank reserves the right to cancel this tour if the minimum number of tour participants is not met. The published price of this tour is based on rates available at the time of booking. First Dakota National Bank reserves the right to increase the cost of the tour, at any time, in the unlikely event that our tour suppliers impose price increases such as, but not limited to, fuel surcharges. Proof of such rate adjustments from our suppliers will be provided.

COVID-19 WARNING: The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization and is reported to be contagious. If I test positive for COVID-19 while on tour, I understand I may have to quarantine for an unspecified amount of time until I am cleared for travel by local authorities. I understand I am responsible for the up-front costs associated with quarantine (lodging, meals, transportation, etc.), if necessary, and that travel protection may not reimburse me for all my out-of-pocket costs.
